REINED WORK JUDGES CARD

1/2 POINT PENALTIES
 Not changing leads simultaneously Over or under spin 1/8 turn
 Jogging first two strides

1 POINT PENALTIES
 Out of lead Out of lead each 1/4 circle
 Slipping rein in the bridle Scotching or anticipating stop
 Over or under spin 1/4 turn Excessive whipping or spurring

2 POINT PENALTIES
 Lead missed around end of arena past second corner
 Not ever changing leads in patterns where there is only 1/2 circle
 Failure to run by marker before stop is initiated
 Freezing up in turn
 Breaking gait
 Jogging beyond two strides
 On trot in patterns, failure to stop before executing a lope departure
 A stop in the first 1/4 of the circle, after a lope departure, is a break of gait

5 POINT PENALTIES
 Spurring or hitting in front of cinch at anytime
 Blatant disobedience including kicking, biting, bucking, rearing, and striking or obviously insubordinate

-0- SCORE
 Not following pattern (i.e. over or under spin more than 1/4)
 Two hands on the reins in a bridle or two-rein class
 Fingers between the reins in a bridle class, except the two-rein class.
 Horse balking
 Bloody mouth (inside)
 Illegal equipment
 Leaving working area before pattern is complete
 Fall of horse or rider
 Backing more than 2 strides when no back up is called for in the pattern
 Jogging in excess of one-half circle or one-half the length of the arena
NE - Failure of an exhibitor to attempt to complete the pattern

MANEUVER SCORES: -1/2 Extremely Poor, -1 Very Poor, -1/2 Poor, 0 Correct, +1/2 Good, +1 Very Good, +1 1/2 Excellent

COW WORK JUDGES CARD

GUIDE FOR "NEW COW" (At judges' discretion, rider will receive new cow(s) as necessary to show horse)

- A. Cow that won't run.
- B. Cow that doesn't respect the horse.
- C. When cow leaves arena.

CREDITS:

- A. Maintaining control of the cow at all times
- B. Exhibiting superior cow sense and natural ability without excessive reining or spurring
- C. Degree of difficulty
- D. Eye appeal

1 POINT PENALTIES

- A. Loss of working advantage
- C. Using corner or the end of the arena to turn cow
- E. Changing sides of arena to turn cow
- W. Excessive whipping, spurring, or hollering
- L. For each length horse runs past cow
- S. Slipping rein
- T. Turning cow before passing middle marker on first turn

2 POINT PENALTIES

- A. Going around corner of arena before turning cow
- B. In an open field turn animal gets within 3 feet of the end fence before being turned

3 POINT PENALTIES

- H. Hanging up on fence (refusing to turn)
- K. Knocking down cow without having working advantage
- E. Exhausting or overworking before circling cow

5 POINT PENALTIES

- A. Not getting a turn each way (5 points each way)
- C. Blatant disobedience including kicking, biting, bucking, rearing, and striking or obviously insubordinate

-0 SCORE

- A. Turn tail
- D. Fingers between the reins in a bridle class, except the two-rein class
- E. Out of control
- F. Bloody mouth (inside)
- G. Illegal equipment
- H. Leaving working area before pattern is complete
- I. Fall of horse or rider
- J. Schooling between rein work and cow work
- K. Schooling horse between cows, if new cow is awarded.
- L. If a rider hits or kicks the animal being worked, with the romal or reins, in an abusive manner.
- M. Failure to quit working a cow after a new cow has been awarded.

NOTE: Judge may blow the whistle at anytime to terminate the work. A score of zero will be given if the work is not complete at that time.

COW WORK SCORING GUIDELINES

75 & higher - Total control. Excellent form & position on animal, high degree of difficulty, excellent eye appeal.

73 - 74 - Good form & position on animal, good control of animal, high degree of difficulty with good eye appeal.

71 - 72 - A credit earning run with correct form and position, better than average control of animal with some degree of difficulty and eye appeal.

70 - Control. Correct form, average degree of difficulty.

68 - 69 - Slight loss of form or position on animal. Average degree of difficulty and eye appeal. Good work with a major penalty (3 or 5) or average work with 1 point penalties.

66 - 67 - Trouble controlling animal and/or rider/horse is out of position. Loss of eye appeal.

65 & below - Incurs major penalties, loss of control and position. Total lack of credit.

NE - Failure of an exhibitor to attempt to complete the work.
